Gifts of Securities you may wish to consider the benefits of making a gift of securities. Some donors find that a gift of this type can provide significant tax advantages. Giving stock that has been held for more than 12 months offers two-fold tax savings: a tax deduction for the full market value of the stock on the day of the gift and capital gains may be avoided.

Matching Gifts many local corporations sponsor matching-gift programs by which an employee's charitable donation is matched with a contribution by the corporation. In this way, donors can easily leverage the value of their contribution; in some cases, the matching contribution is as high as three to one.

Stilling's Grant

Acres Conserved: 27.5

• Type Project: Land Donation to FLT

Project Timeline: 2017 - 2018

• Benefits: One of the oldest farms in Falmouth, records show it was originally purchased by John Morrill Jr. from the Waldo family in 1798. John Morrill's daughters became the owners in the early 1800s. At one point, the farm was a productive Peony farm, and Mt. Washington could be seen from the top of the field. This year, Bruce and Suzanne Stillings, who have owned the farm since 1998, ensured that the farm will be protected forever. The Stillings are donating the 27+ acres of fields and woods to the Falmouth Land Trust. FLT will conserve the property in perpetuity allowing the wildlife, which is abundant on the property, to continue to thrive in the watershed of Highland Lake. The farm has excellent examples of agricultural heritage stone walls, creating a snapshot of historical farming in rural Maine. In the future, the farm will provide opportunities for birdwatching and walks in a peaceful wooded area.

Buck-Chase Parcel – North Falmouth **Community Forest**

 Acres Conserved: 106.8 Project Timeline: 2015 - 2018

• Type of Project: FLT Easement, Town-owned Property

 Benefits: This addition to the North Falmouth Community Forest ensures its

North Falmouth community forest is part of a contiguous block of habitat consisting of approximately 400 acres of upland mixed hardwoods. North Falmouth is one of the most beloved mountain biking spots in southern Maine and it is full of trails that suit walkers, bikers and runners. It is also one of the most remote natural areas in Falmouth, making it an attractive haven for wildlife such as fishers, porcupines, bobcats, and songbirds.

Stillings Field

• Acres Conserved: 25.6

• Project Timeline: 2016 - 2018

• Type of Project: FLT Easement, Town-owned Property

• Benefits: This open space provides a potential for meadow habitat as well as woods edge habitat suitable for swooping predators such as owls and myotis (mouseeared) bats, which need wide spaces to hunt insects. This scenic field, located along bikers and others passing along the road corridor. There is a small parking area in the southern corner of the property with access to the trails and field.

Suckfish II -**Suckfish Conservation Area**

Acres Conserved: 31.58

• Project Timeline: 2016 - 2018

• Type of Project: Easement, Town-owned Property

• Benefits:This project protects the shore of Highland Lake from future development, thus safeguarding the water quality and endangered aquatic species identified in the area. The property also provides habitat for Bald Eagles, which in the last decade were removed from the endangered species list, and other native wildlife species in the mixed hardwood uplands that comprise much of this



SHAPING THE FUTURE: JUNIOR NATURALIST & YOUTH LEADERS TEAM UP WITH FALMOUTH LAND TRUST.

Falmouth Land Trust continues to strengthen its programming with young people in an effort to connect our community members and their families to our landscape. Kate Nicoll. FLT's outreach and education coordinator, is working with elementary schoolers in an afternoon program offering aspiring junior naturalists the opportunities to learn more about the world they inhabit. Kate continues to offer recess trail walks during the day at Falmouth

Elementary School allowing students a auieter outdoor option to recess excitement. At the high school level, FLT is hosting five Falmouth seniors who have selected the Land Trust as the organization they will serve during a leadership development program being piloted this year with the Service Learning Club. The seniors will work on stewardship and management activities to help sustain the ecological values and improve access at the McCrann Preserve.

LAND CONSERVATION UPDATE: NEW PROPERTIES PROTECTED.

The Falmouth Land Trust has permanently conserved 1,700 acres of land in Falmouth since its inception in 1981. Our portfolio includes 48 parcels of land – some private, some public and some owned in fee by our organization. This year we have added newly protected acres to our list of forever open spaces. See page 3 for additional information about the new properties.

FARM UPDATE: FIRST FARMING SEASON A SUCCSESS!

In its first growing season, the Hurricane Valley Farm produced approximately 11,000 pounds of locally grown produce for families in Maine. This amount of food represents a milestone for our community as well as the Hurricane Valley Farm project, which has a long-term vision to develope sustainable agriculture over the next decade. The 62-acre property was purchased by the Falmouth Land Trust in 2015. Next year, our partner, Cultivating Community, anticipates adding

additional garden plots to the community gardening area, expanding the number of participating farmers and developing a small apiary program for honey and pollination. This past summer, Cultivating Community had four farmers working at the Hurricane Valley Farm growing vegetables for markets in their farmer training program, which will also be expanding in the future. The trails at HVF are open to people who wish to take a walk or run on the property.
